SECTION 1 - EXPENSES

Meeting expense allowances shall be provided to the FVDC Officers, upon submission of a completed expense claim form, to cover meals and mileage:

Secretary	\$50.00

SECTION 2 - DEPENDANT CARE

Eligibility - delegates attending District Council meetings and/or officers attending FVDC meetings and/or business are entitled to the following, subject to submission of receipts:

Full Day	up to \$45.00 per dependant
Half Day	up to \$25.00 per dependant

Dependant care is authorized for children or dependant adults within the member's household.

SECTION 3 - ACCOMMODATION

If accommodation including room, taxes and parking, is required by an Executive Board Officer, it will be paid or reimbursed at the prevailing rates and upon submission of receipts.

SECTION 4 - REGIONAL and ALTERNATE VICE PRESIDENTS

The Regional Vice President is to attend all meetings of the CUPE BC Executive Board and provide a written and verbal report at the following FVDC Executive and General meetings.

The Alternate Regional Vice President is to attend a minimum of three (3) CUPE BC Executive Board meetings as well as to attend any meetings that the Regional Vice President cannot attend. The Alternate Regional Vice President shall provide written and verbal reports of these meetings to the FVDC Executive and members.

SECTION 5 - CUPE BC COMMITTEE REPRESENTATIVES

Members representing the FVDC on CUPE BC Committees are required to attend all arranged committee meetings. If a committee meeting cannot be attended, it is the representative's responsibility to obtain the details of the meeting missed.

The Committee Representative is to provide a written report to the Secretary, as well as a verbal report to the FVDC membership at the next General meeting of the District Council.
